1. (Pricing) Can we submit Xactimate Pricing which is industry standards?

Answer: Yes

2. In regards to the project above, have an estimated budget and start date been established?

Answer: Our Fiscal years run from July 1 to June 30.

FY 2017 - CCSD spent \$232,583

FY 2018 - CCSD has spent so far \$129,624

There is an approximate budget of about \$200,000, but it depends on the weather. If we have major storms or hurricanes this number can go up.
