## **Angel Oak Elementary - Pat Cline**

Angel Oak Elementary SIC meeting February 11, 2021

- Principal Condon gave a school update. 87% of student are back in person. 84 students are served through regional
  and temporary remote instruction. There are currently no school student clubs, however tennis will begin soon.
   Students attending in person are performing significantly better than those attending virtually. Several grade levels
  are planning virtual parenting events to target specific students for support at school and home.
- - -Instructional Coach, Parent Advocate, Guidance Counselor (3-5) and Computer Science/Tech/STEAM teacher.
- Currently Title 1 students are 59.6% of the 650 total students enrolled. A comprehensive needs assessment will be conducted by the Title 1 Team in March/April to make decisions regarding Title 1 funding for next year.

## Mt. Zion Elementary – Tamy Lockhart

Mt. Zion's SIC was moved out a week and is now scheduled to be held Wednesday, February 17<sup>th</sup>.

## St. John's High - Dr. Karen Simmons

- 30 additional students returned to school for the second semester.
- 130 students have a grade of D or below.
- Mr. Larson continues to explore various methods of capturing failing students and providing the support needed to help them improve their grades.
- The Upgrade Program (mentioned during the February 2<sup>nd</sup> meeting) is scheduled to start on Saturday. Mr. Larson is looking for adults to come out and help with the students.
