- I. Call to Order: Meeting was called to order at 6:pm  
In attendance: Sarah S. Johnson, Pamela Jouan-Goldman, Marty Belk, Kristen Cassi (6:03pm)
- II. Approval of Agenda  
Ms. Belk moved to approve the agenda as presented, Ms. Jouan-Goldman seconded. Motion passed (4-0)
- III. Approval of Minutes  
Ms. Belk moved, Ms. Jouan-Goldman seconded a motion to approve the February 5, 2020 minutes. Motion passed (4-0)
- IV. Cario Middle School presentation by Principal Gayle Morris. Handout of slide presentation given to board members.
- V. Public Comment  
Michael Antonelli, Principal at Carolina Park Elementary, spoke briefly about the school's expected growth and overcrowding concerns.

A motion was made by Ms. Johnson, seconded by Ms. Jouan-Goldman to go into executive session. Motion passed (4-0).

- VII. Vote on Executive Session Item(s)
  - A. In lieu of expulsion place the student at Daniel Jenkins Academy on board probation for the remainder of the school year. Student will remain at Daniel Jenkins Academy until successful completion of the program. Motion passed (4-0).
  - B. In lieu of expulsion placement at Turning Point Academy for a minimum stay of 30 days. Transportation is not provided. Student may return to school after successful completion of the

program. Student will remain on strict district probation for the remainder of the 2019-2020 school year. Student is not allowed to attend any evening recreational activities for the remainder of the school year. This includes all CCSD campuses. Motion passed (4-0).

C. In lieu of expulsion placement at Turning Point Academy for a minimum stay of 30 days. Transportation is not provided. Student may return to school after successful completion of the program. Student will remain on strict district probation for the remainder of the 2019-2020 school year. Student is not allowed to attend any evening extracurricular activities for the remainder of the school year. This includes all CCSD campuses. Motion passed (4-0).

VIII. Carolina Park Elementary Rezoning

- A. Mr. Jeff Borowy, COO, presented current enrollment numbers and enrollment projections for the next 5 years. Handout received
- B. A motion was made by Ms. Johnson, seconded by Ms. Cassi, that the scope of rezoning plans will only include Carolina Park Elementary. Motion passed (4-0).
- C. A motion was made by Ms. Johnson, seconded by Ms. Jouan-Goldman, that the new attendance zones will be implemented for the 2021-2022 school year. The new attendance zones will be announced sometime by the fall of 2020. Motion passed (4-0).
- D. A motion was made by Ms. Johnson, seconded by Ms. Belk, that the following guidelines for rezoning be adopted. Motion passed (4-0).
  - 1. Consider current enrollment and capacities at campuses
  - 2. Enable all schools to offer comparable curriculum offerings
  - 3. Facilitate the neighborhood/feeder school concept
  - 4. Consider overall socioeconomic demographics
  - 5. Analyze traffic patterns to shorten travel time
  - 6. Review Five Year Plan for school attendance zones
