I. Call to Order:

The board meeting was called to order at 5:12 p.m. by Chair, Rodney Lewis.

If the student cannot successfully complete TPA, the student will be assigned to Daniel Jenkins Academy on strict board probation until successful completion of the program. The board approved 3-0.

David Bell moved, with a second by Jennifer Osteen, to place student 8.49.19 at Turning Point Academy (TPA) on strict board probation for a minimum stay of 45 days. If the student cannot successfully complete TPA, the student will be assigned to Daniel Jenkins Academy on strict board probation until successful completion of the program. The student will not be allowed to have a cellular device in school. The board approved 3-0.
