- I. Call to Order: Meeting was called to order at 6:01pm

- II. Approval of Agenda
  Ms. Belk moved to approve the agenda with amendment to include an Adult Education application, Ms. Jouan-Goldman seconded. Motion passed (4-0)

    - 1. In lieu of expulsion placement at Turning Point Academy for a minimum stay of 45 days. No cell phone usage while at school. Student is not allowed to have a cell phone on campus, but if needed student must submit phone to administration until the end of the day. Student must report to all classes as assigned. Failure to do so will result in a refusal to obey/defiant infraction with the appropriate consequences assigned. Student must report all concerns to the school administration. Student should not address any

- concerns without an adult present and leading the session. Failure to do so will result in a refusal to obey/defiant infraction. Student will be on strict board probation for the remainder of the 2019-2020 school year. Motion passed (4-0).
- 2. In lieu of expulsion return student to school of strict district probation for the remainder of the 2019-2020 school year. Student should not address any concerns without an adult present and leading the session. Failure to do so will result in a refusal to obey/defiant infraction. Motion passed (4-0)
- B. Student Transfer Request
  - 1. Motion to approve transfer request #65387. Passed (4-0)
- C. Adult Education Application
  - 1. Adult Education Application review and motion to approve by Ms. Johnson, seconded by Ms. Jouan-Goldman. Motion passed (4-0)
