I. Call to Order:

The board meeting was called to order at 6:02 p.m. by Ms. Jouan-Goldman.

II. Adoption of Agenda:

Ms. Jouan-Goldman moved, with a second by Ms. Krause, to adopt the agenda. The motion passed 3-0.

A. Discipline Hearing

Student 1 – A motion was made by Mr. Tezza, seconded by Ms. Krause, to allow the student to return to school on strict board probation for the remainder of the school year. The student will be required to check-in weekly with school administration. The motion passed 3-0.

Student 2 – A motion was made by Ms. Jouan-Goldman, seconded by Ms. Krause, to expel the student from Charleston County School District for the remainder of the school year with services. The motion passed 3-0.

Student 3- A motion was made by Ms. Jouan-Goldman, seconded by Ms. Krause, to place the student at Turning Point Academy (TPA) for a minimum stay of 45 days on strict board probation. If the student cannot successfully complete TPA, the student will

be assigned to Daniel Jenkins Academy until successful completion of the program. The student will continue with the ADAPT program. The motion passed 3-0.

B. Student Transfer Reconsideration

Motion was made by Ms. Krause, seconded by Mr. Tezza to deny the request for reconsideration. The student will remain on the waiting list. Motion passed 3-0.
