August 11, 2020

I. Call to Order & Moment of Silence:

The board meeting was called to order at 5:03 p.m. by the Board Chair, George Tempel, followed by the Pledge of Allegiance and a moment of silence.

II. Adoption of Agenda:

Proceedings:

Sue McManus moved, with a second by Cynthia Smalls, to approve the agenda as written. The motion passed 4-0.

III. Approval of Minutes:

VIII. District Updates:

Board Liaison, Michelle English-Watson shared brief updates on the following:

A. James Island Bus Lot

Staff is continuing due diligence on a potential piece of property. Due diligence and site plan completion have uncovered several factors that can impact cost to develop and the number of buses placed on property. Staff is exploring an additional parcel that adjoins the current property to expand the footprint. This could possibly address

the majority of the issues. Staff will also be meeting with City of Charleston Planning staff to revisit the proposed JICHS bus lot site that was denied by the BZA.

B. Camp Road Middle School Construction

Although construction continues, water flow to the building is not in place and is negatively impacting planned safety inspections. The state final inspection for building occupancy is now projected between August 27th and September 1st. Staff continues to work with agencies to adjust inspection dates pending the water availability as well as working on contingency plans to support the school's needs.
