If the student cannot successfully complete Turning Point Academy, the student will be assigned to Liberty Hill Academy on strict board probation until successful completion of the program. The student will also be required to write a 1000 word essay on *Respect* that is due to the board by September 30, 2019. Lastly, The student will not be allowed to have access to a cellular device while in school. The board approved 3-0.

8.85.18 – A motion was made by J. Osteen, seconded by C. Anderson, to place student 8.85.18 at Turning Point Academy on strict board probation for a minimum stay of 30 days. If the student cannot successfully complete Turning Point Academy, the student will be assigned to Liberty Hill Academy on strict board probation until successful completion of the program. The student will also be required to write a 1000 word essay on *Respect* that is due to the board by September 30, 2019. Lastly, the student will not be allowed to have access to a cellular device while in school. The student will be required to reappear before the District 10 board prior to returning to the zoned school. The board approved 3-0.
