VII. <u>Vote on Executive Session Item:</u>

5.1.21 – A motion was made by Monica Smith, seconded by Renea Bligen, to allow student 5.1.21 to return to school on strict board probation for the remainder of the 2021-2022 school year. will not be allowed to have a cellular device while in school. The student will be required to turn the phone in to the office at the start of the school day and retrieve it at the end of the day. The student will also be required to write a 1,000-word essay to be written on "Cyberbullying." The motion was deadlocked with a vote of 3-3 (Pat Cline, Rev. Gertie Ford, and Leon Green opposed).

A motion was made by Rev. Gertie Ford, seconded by Pat Cline, to place the student in the District's Turning Point Academy for a minimum stay of 30 days on strict board probation. If the student cannot successfully complete Turning Point Academy, the student will be placed at Liberty Hill Academy until successful completion of the program. As part of the student's probation, the student will not be allowed to have a cellular device while in school. The student will be required to turn the phone in to the office at the start of the school day and retrieve it at the end of the day. The motion was deadlocked with a vote of 3-3 (Monica Smith, Renea Bligen, and Dr. Karen Simmons opposed).

A motion was made by Renea Bligen, seconded by Leon Green to table the decision in the case of student 8.2.21 until the next meeting (October 19, 2021). The motion passed 5-1 (Pat Cline opposed).

Mr. Briggman welcomed and introduced Dr. Gerrita Postlewait, Superintendent of Schools.
