Regular Board Meeting Minutes

St. Andrew's Campus, Media Center

November 21, 2019

I. Call to Order & II. Adoption of Agenda:

The board transitioned into the Regular Meeting following the Special Called Meeting.

III. Approval of Minutes:

David Bell moved, with a second by Jennifer Osteen, to approve the November 7th and November 14th meeting minutes. The motion passed 3-0.

IV. Executive Session (Discipline Hearings):

Jennifer Osteen moved, with a second by David Bell, to move into Executive Session. The motion passed 3-0.

V. Open Session Reconvened:

Jennifer Osteen moved, with a second by David Bell, to return to Open Session. The motion passed 3-0.

VI. Vote on Executive Session Items:

Jennifer Osteen moved, with a second by David Bell, to place student 8.16.19 in the district's Turning Point Academy for a minimum stay of 45 days. The student will also be required write a 1500 word essay on *Plessy vs. Ferguson*. Secondly, the student will be required to write a letter of apology to the entire WAHS student body. Lastly, the student will not be allowed to have a cellular device in school for the remainder of the 2019-2020 school year. The motion passed 2-1 (Jennifer Osteen opposed).

David Bell moved, seconded by Jennifer Osteen, to allow student 8.15.17 to return to school on strict board probation for the remainder of the 2019-2020 school year. Secondly, the student will be required to write a letter of apology to the entire WAHS staff & student body. The letter is due by December 20, 2019. Lastly, the student will not be allowed to have a cellular device in school for the remainder of the 2019-2020 school year. The probation contract is attached.

A motion was made by Jennifer Osteen, seconded by David Bell, to rescind the decision for student 8.16.19. The board approved 3-0.

A motion was made by Jennifer Osteen, seconded by David Bell, to allow student 8.16.19 to return to school on strict board probation for the remainder of the 2019-2020 school year. The student will be required write a 1500 word essay on *Orangeburg Massacre*. Secondly, the student will be required to write a letter of apology to the entire WAHS staff and student body. The essay and letter of apology are due by December 20, 2019. Lastly, the student will not be allowed to have a cellular device in school for the remainder of the 2019-2020 school year. The board approved 3-0.

A motion was made by Jennifer Osteen, seconded by David Bell, to allow student 8.17.19 to return to school on strict board probation for the remainder of the 2019-2020 school year. The board approved 3-0.

VII. Public Comments:

Eight guests signed up for public comments.

District 10 parents, teachers, and community members shared concerns (both in support of and opposing) regarding the Middle Schools merger. A list of questions was shared with the board with a request to provide responses as soon as possible. Dr. Joseph Williams provided shared next steps in the process and shared that information will be available on the District 10 page of the CCSD website.

VIII. District Updates

Michelle Simmons, District 10 Liaison shared that the Committee of the Whole and Board of Trustees meeting is scheduled for Monday, December 16th. Ms. Simmons also shared that the county board voted on the following items during the November 11th Committee of the Whole meeting.

- Work with the Constituent District 10 board to create a small attendance zone for Ashley River Creative Arts Elementary School. ARCAE would also serve as a District 10 constituent magnet.
- Work with the Constituent District 10 board to study the impact of eliminating partial magnet status at St. Andrews School of Math and Science and bring a recommendation to the Board by July 2020 for implementation in the 2021-22 school year. *The board voted to take no action on this item.*
