Using the capacity factor of 22 allows for an even spread of classes throughout the school without knowing the

**Teaching Stations** per the CCSD education specifications a standard classroom is 850 square feet. The SCF is reduced to accommodate for the smaller than standard room. Classrooms that are smaller than 599 sq ft are not considered as teaching stations.

#### Middle/High Schools:

- 28 students per class (core classes) to 40 students per class (orchestra)
- For building operating capacity, take the lowest number of students (28)
- Take into account planning periods and lunch, which is 25% of the day

28 students per teaching station x .75% usage = 21 students/TS

Using the capacity factor of 21 allows for an even spread of classes throughout the school without knowing the programing.
