VIII. Constituent District 1 Liaison Report

- A. Early Childhood Program Updates Ms. Kimberly Foxworth, Executive Director of Early Childhood, Constituent District 1 Liaison
 - 1. Enrollment: 11 Head Start and 20 Early Head Start students. Enrollment continues throughout the summer.
 - 2. The Early Head Start Lead candidate recommendation is going through the clearance process.
 - 3. The current curriculums are insects and balls.
 - 4. The moving up ceremony will be on May 30th.
- B. Charleston County School District News/Updates Ms. Kimberly Foxworth, Executive Director of Early Childhood, Constituent District 1 Liaison
 - 1. The first reading of the budget took place last night during the Board meeting.
 - 2. The ESSER funds continue to be monitored.
- C. St. James-Santee Elementary/Middle School Ms. Dee Andria Brown and Ms. Rudell Burch, Assistant Principal, St. James-Santee Elementary/Middle School
 - 1. The end of the year activities are underway; Muffins for Mom took place earlier this month as did a parent informational meeting, and 8th-grade graduation is this Thursday.
 - 2. SC Ready testing along with Algebra I and Spanish testing are taking place; the children are focused; books have been received and are ready for the students to read over the summer; the English curriculum for next year has arrived; the Career Fair will take place tomorrow; the May Day event will be held Friday; Summer School will take place again this year; individual classroom celebration dates are posted online.
- D. Wando High School Ms. Chayann Simpson and Rev. Milligan, and Ms. Pamela Jubar, Associate Principal, Wando High School
 - 1. 1,178 AP tests were proctored; 4 State Championships: girls swimming, boys and girls lacrosse teams, and girls soccer; 33 athletes have committed to colleges; graduation will take place on June 3rd; three seniors have committed to academies; summer school begins June 13th with 150 slots for eligible students who scored between 50-59; please submit community member names that may want to volunteer; 256 students were zoned for the McClellanville/Awendaw area.
- E. Awendaw Property Update Ms. Kimberly Foxworth, Executive Director of Early Childhood, Constituent District 1 Liaison
 - 1. No updated information for the Awendaw Property.
 - 2. Ms. Foxworth addressed questions previously submitted by Mr. Collenton The Outer Banks movie company will be filming on the McClellanville Middle School property over the next few weeks. There is a For Sale sign posted on the property. The property is still for sale. The real estate firm is CC&T Real Estate. The asking price is \$1.7 million.

- 3. Ms. Foxworth will seek information regarding the new district 9 elementary school in order to answer Rev. Milliagan's previous question.
- 4. Ms. Foxworth will seek an answer to Rev. Milligan's inquiry about what will be done with profit from the sale of the building.
- 5. Ms.Geathers inquired about the signage for the new building.
