

ALLEGRO CHARTER SCHOOL OF MUSIC PROVIDES A DIVERSE BODY OF STUDENTS AT THE MIDDLE AND HIGH SCHOOL LEVEL ON THE PENINSULA OF CHARLESTON A RIGOROUS EDUCATION WITH MUSIC INFUSED INTO ALL ASPECTS OF LEARNING. ALLEGRO HAS A STUDENT BODY THAT MIRRORS THE RACIAL AND SOCIOECONOMIC DIVERSITY OF ITS COMMUNITY. STUDENTS AT ALLEGRO COME FROM BACKGROUNDS IN BOTH FAILING SCHOOLS AND HIGH-ACHIEVING SCHOOLS. OUR STUDENT BODY HAS MANY STUDENTS WHO ARE GIFTED, AND AN ALMOST EQUAL NUMBER OF STUDENTS WITH SPECIAL NEEDS.
