 - Parents' right to be involved in their children's education.

The school will offer a flexible number of meetings and parent/guardian trainings at convenient times for parents/guardians to participate, give suggestions and take part in decisions regarding the instructional program of the school. The school will hold Open House, Coffee with the Principal, Instructional Nights and other events to provide parents/guardians with information about the Title I program and the school's academic achievement. If requested by parents/guardians, other opportunities for regular meetings to formulate suggestions and participate in decisions related to their children's education will be provided.

The school will conduct curriculum nights that focus on core content areas where parents/guardians will participate in interactive activities with their children. Copies of the grade level standards will be provided. During the Annual Meeting, an explanation of ACADEMIC DATA and proficiency levels will be given to parents/guardians. Additionally, tips and suggested activities will be provided on how parents/guardians can work with teachers and monitor their children's progress.
- 8. The school will coordinate and integrate parent and family engagement programs and activities with our Montessori and Traditional Programs in order to encourage and support parents/guardians participating in the education of their children. Parents/Guardians in these programs will be invited to participate in school level trainings, workshops and events.
