- I. **Call to Order:** The meeting was called to order at 5:33pm.

- C. Student Expulsion Hearing C: A motion was made by Ms. Johnson, seconded by Ms. Cassi that in lieu of expulsion the student is to be placed at Liberty Hill Academy until successful completion of the program. Motion passed 3:0.
- D. Student Expulsion Hearing D: Hearing to be re-scheduled.
- E. Student Expulsion Hearing E: A motion was made by Ms. Johnson, seconded by Ms. Cassi to return the student to school on district probation until the end of the 2018-19 school year with 20 hours of community service to be completed by March 1, 2019 and a letter of apology written to Wando High School and delivered to Mr. Blankenship by December 20, 2018.
