- I. Call to Order: meeting was called to order at 6:07 pm.
In attendance: Sarah Johnson, Marty Belk, Kristen Cassi. Trey Tezza arrived at 6:30pm.
- II. Approval of Agenda
Ms Belk moved, Ms. Cassi seconded a motion to approve the agenda. Motion passed 3:0.
- III. Approval of Minutes
Ms Belk moved, Ms. Cassi seconded a motion to approve the minutes with the changes to the wording of the student transfer identities. Motion passed 3:0.

A motion was made by Ms. Belk, seconded by Ms. Cassi to go into Executive Session. Motion passed 3:0.

- IV. Student Expulsion Hearings (6)

A motion was made by Ms. Johnson, seconded by Ms. Cassi to return to open session. Motion passed 4:0.

- V. Vote on Executive Session Item
 - A. A motion was made by Ms. Johnson, seconded by Ms. Cassi to return Student A to school on district probation until the end of the school year with random searches until the end of the school year. Student is also to complete a one page paper on the dangers of vaping. Motion passed 3:0. A motion was made by Ms. Johnson, seconded by Ms. Cassi to add a due date for the paper of May 17, 2019. Motion passed 3:0. Mr. Tezza abstaining from vote as he was not present for hearing.
 - B. A motion was made by Ms. Johnson, seconded by Ms. Cassi to return Student B to school on district probation until the end of the school year with random searches until the end of the school year. Student is also to complete a one page paper on the dangers of vaping and 15 hours of community service by May 17, 2019. Motion passed 4:0.

- C. A motion was made by Ms. Johnson, seconded by Ms. Cassi to return Student C to school on district probation until the end of the school year with random, weekly searches until the end of the school year. Student is also to complete a one page paper on the dangers of vaping and 20 hours of community service by May 17, 2019. Motion passed 4:0.
- D. A motion was made by Ms. Johnson, seconded by Ms. Cassi that in lieu of expulsion Student D is to be placed at Turning Point Academy for a minimum of 45 days and to be on district probation until the end of the school year with random searches through the end of the school year and a referral to the ADAPT program. In addition the student is to complete 10 hours of community service by May 17, 2019. Motion passed 4:0
- E. A motion was made by Ms. Johnson, seconded by Ms. Cassi that in lieu of expulsion Student E is to be placed at Turning Point Academy for a minimum of 45 days. Motion passed 4:0. A motion was made by Mr. Tezza and seconded by Ms. Cassi to reconsider the vote. Motion passed 4:0. A motion was made by Mr. Tezza and seconded by Ms. Cassi to amend the original motion with the addition of a referral the District ADAPT program. Motion passed 4:0.
- F. A motion was made by Ms. Johnson, seconded by Ms. Cassi to reschedule the hearing for Student F to 9:15pm Wednesday March 20, 2019. Motion passed 4:0.
