 - a. A moderator will be appointed by a majority vote of all trustees present.

III. Voting

A Resolution Requesting The Charleston County Legislative Delegation To Introduce Legislation To Amend South Carolina Act 340 Of 1967.

WHEREAS, South Carolina Act 340 of 1967 created the Charleston County School District, consolidated the eight school districts within the county, and abolished the County Board of Education of Charleston County, and

WHEREAS, the respective eight school districts were created as special districts, known as constituent districts, for the administrative purposes set forth by the act, and

WHEREAS, the General Assembly of South Carolina has passed many subsequent acts amending South Carolina Act 340 of 1967 that have drastically reduced the functions delegated to and devolved upon the trustees of the constituent school districts in the original act, and

WHEREAS, South Carolina Act No. 721 of 1978 amended Act 340 of 1967 transferring the function of principal employment from the constituent districts to the consolidated district, and

WHEREAS, South Carolina Act No. 131 of 2007 amended Act 340 of 1967 transferring the function of employment of all school personnel from the constituent districts to the consolidated district, and

WHEREAS, the boards of trustees of the eight constituent school districts of the Charleston County School District now lack the authority to take the means necessary to improve education within their respective districts, and

NOW, **THEREFORE**, be it resolved that the Trustees of the Constituent School Districts of Charleston County hereby request that the Charleston County Legislative Delegation introduce legislation to repeal South Carolina Act No. 721 of 1978 and Act No. 131 of 2007.
